tax benefits

Kettle's Yard is an institution of the University of Cambridge. The University of Cambridge is an exempt charity and is recognised by HM Revenue & Customs as having charitable status for all UK tax purposes. Bequests or legacies may be made to Kettle's Yard free of UK Inheritance Tax and Capital Gains Tax.

If you find yourself a beneficiary of a will, you can transfer all or part of your inheritance to Kettle's Yard under a Deed of Variation. Amounts transferred are free of Inheritance Tax.
