KETTLE'S YARD COMMITTEE RESPONSIBILITIES

As a committee member, you will be expected to:

- Attend four committee meetings a year. These meetings are usually on Thursdays from 4-6pm in person at Kettle's Yard. When members are unable to attend in person, they can attend remotely.
- Attend a Strategic Planning Day every 12-18 months, usually at Kettle's Yard.
- Some members of Committee may from time to time meet with the wider team at Kettle's Yard to support specific areas of work, these meetings can usually be virtual.
- Provide strategic support and advice and acting as a critical friend.
- Monitor and review Kettle's Yard's commitments to Arts Council England (Kettle's Yard is regularly funded by ACE as a National Portfolio Organisation), ensuring we are achieving our agreed outcomes and embedding the four 'Investment Principles': Ambition & Quality, Environmental Responsibility, Dynamism and Inclusivity & Relevance.
- Take time to prepare for meetings by reading and reviewing circulated papers.
- Support the Chair to ensure strong governance and accountability.

- You do not need any qualifications to be considered for the role.
- We particularly welcome applications from disabled people and people of colour as these are currently under-represented on our Committee.

To make outstanding exhibitions: Celebrating art and artists of the 20th and 21st centuries. An exhibitions programme which champions diversity, draws on research and inspires creativity.

To launch and develop 'Perspectives': A platform for commissioning and sharing research, projects and programmes, deepening understanding and knowledge of the house and collection, and our wider programme, through many voices and stories.

To inspire and engage young people, children and local communities: Building on long standing creative programmes with young people, schools and communities and offering new opportunities for students at the University of Cambridge.

To devise and implement a new Research Strategy: Strengthening Kettle's Yard role as a resource and catalyst for research and insight, through new programmes and publications.

To implement a major fundraising campaign: To build the endowment by £5m by 2027, Kettle's Yard's 70th anniversary, so we can plan ahead and sustain our reputation for excellence and innovation.

Running through the Five Ambitions, and across all of Kettle's Yard's work, is a continuing commitment to anti–racism and to environmental responsibility. These key areas of organisational review and change are subject to separate action plans.
